2. SUBSEQUENTLY THE SELECTED CANDIDATES WILL BE PROVIDED WITH FORMATS FOR SURETY BOND AND AGREEMENT AS PRESCRIBED BY THE DEPARTMENT. THEY WILL BE CALLED FOR SIX MONTHS INDUCTION TRAINING FOR THE POSTS OF JPA/JSK AT MUMBAI ON ACCEPTANCE OF THEIR SURETY BOND AND AGREEMENT.
3. THE APPOINTMENT /ABSORPTION WILL BE SUBJECT TO AVAILABILITY OF VACANCIES, MEDICAL FITNESS AT THE TIME OF REPORTING FOR INDUCTION TRAINING, THE CANDIDATES' SUCCESSFUL COMPLETION OF INDUCTION TRAINING, FULFILLING THE RECRUITMENT NORMS, SATISFACTORY VERIFICATION OF CHARACTER & ANTECEDENTS OF THE CANDIDATE, VERIFICATION OF CASTE CERTIFICATE, VALIDATION OF CASTE CERTIFICATE (IN CASE OF MAHARASHTRA), AND OTHER GOVERNMENT ORDERS FROM TIME TO TIME.
4. WAITING LISTS WILL BE OPERATED ONLY IN THE EVENT OF NON-ACCEPTANCE OF THE CANDIDATES FROM THE SELECT LIST OR A CANDIDATE REPORTED FOR TRAINING SUBSEQUENTLY RESIGNS OR DIES WITHIN A PERIOD OF TWO MONTHS FROM THE DATE OF COMMENCEMENT OF INDUCTION TRAINING.
